Validation as a Service Model

CAI works with many companies in early phase clinical trials for whom speed to patient is of the utmost necessity. Often such companies don't need a large internal validation department, and no especial reason to maintain a robust validation program.

By deploying Kneat, CAI was able to establish an in-house program with standardized procedures and off-the-shelf content that can be immediately deployed on a project-by-project basis. For common systems, pre-approved templates can be used without even waiting for pre-execution review. As a result, projects can be initiated more rapidly, with document development times reduced or even eliminated in some cases.

THE CHALLENGE

Slow and Difficult Project Initiation

Often when working with small companies and startups, there exists little or nothing in the way of what validation professionals are accustomed to existing a priori of project initiation. Large established drug companies have global validation groups with detailed standards and procedures for how to do this work, while small and medium sized companies usually have much less, or even nothing, in this regard. As a result, every project requires the development of a new project plan, approach, protocol templates, etc. Even when the project team starts with existing examples or templates, first contact with customers usually results in significant changes and several rounds of review before executable documents are available.

- Pre-approved verification checklists for the disposition of CTCs
- Controlled templates built around SOP for application to other systems.

Application of the Validation as a Service Model to a Small CDMO

The Validation Plan took minimal time to generate, as it simply referenced CAI's pre-approved program and identified the equipment in scope. In addition, for controlled temperature chambers, CAI's program allowed field execution of standard off-the-shelf protocols immediately upon approval of the validation plan, with minimal document development cost.

By virtue of a fully vetted internal program, with deliverables pre-approved by internal Quality, Compliance, and Regulatory specialists, the customer was able to treat CAI as a "fire and forget" solution, allowing their staff to focus on their other duties and minimize distractions during the project timeline.


Major Win

30% Reduction in Project Budget

CAI was able to immediately begin field execution, which resulted in the rapid identification of several equipment issues that needed to be addressed. In particular, a series of freezers were found to be unable to consistently achieve the required temperature range. This required long-lead corrective action that could not have been accomplished within the project schedule if execution had been delayed.

Project Results

- CAI was able to minimize document development costs, saving roughly 20-30% of project budget as compared to traditional approaches.
- CAI completed its scope of work under budget and ahead of schedule: Other firms NOT using Kneat quoted over \$400k for this project's scope. However, CAI quoted 220k, and all work was completed for under \$170k.
